- Evaluate approaches to ethical decision-making while considering basic ethical principles, theories and the cultural context in which decisions are made.
- Identify clinical options and the ethical issues that those options may present based upon stakeholder values and beliefs.

It is intended to improve ethical awareness and knowledge for those dealing with clinically and ethically complex situations. The Healthcare Ethics ECHO is collaborative in nature and provides a learning venue suitable for ethics committee members and health care providers from all disciplines.

HOW DOES IT WORK?

- Join an online video conference once per month over the lunch hour.
- Participants will need access to internet, webcam and microphone.
- Discuss:
 - Clinical case presentations
 - A brief educational presentation by an expert in health care ethics
- Complete evaluation of ECHO programming.


